Sir.

I am directed to refer to the subject cited above and to say that two/ three tier pay scales were given to certain categories of post in the pre-revised pay scale w.e.f 01/01/1996. These scales remained operational till 26/08/2009. As a consequence of revision of pay scales w.e.f 01/01/2006 it was decided that the cases of the officers/ officials who were eligible in the next higher pay scales in the two/ three tier pay scales under the pre-revised pay scales, may not be considered after 26/08/2009 vide this department letter No Fin(PR)B(7)-1/98 dated 31/08/2009. The benefits admissible upto 26/08/2009 had been protected as per as per Rule-11-A of Himachal Pradesh Civil Services (Revised Pay) Rules, 2009.

Now after careful consideration of the matter the Governor, Himachal Pradesh, is pleased to re-introduce the process of granting two tier pay scales, in the revised pay structure, by granting the revised corresponding pay structure to the category of Architects in Public Works Department as per the schedule appended to the H.P. Civil Services Revised Pay) Rules, 2009, with immediate effect. Consequently, two
