Policy regarding permanent absorption of surplus staff taken on secondment basis by the State Government-Clarification thereof.

Sir,

I am directed to invite a reference to this department O.M. No.Fin(C)F(1)2/2012, dated 11<sup>th</sup> May,2012 on the subject cited above and to say that Condition No.3 of the above referred O.M. provides that the permanent absorption shall be strictly in the revised Pay Band + Grade Pay corresponding to the pre-revised pay scale of the post. In case of any official working in higher pay scale in the cadre as a result of grant of benefits under ACPS in the parent Department at the time of his/her absorption, only the basic pay of such employee shall be protected and the difference shall be added in the pay in the pay band and he/she will get their annual increment in a normal course.

Some departments have been seeking clarification on this issue. The matter has been re-considered and it has been decided that in case of any official working in higher pay scale/grade pay in the parent cadre as a result of grant of benefits under ACPS, the higher pay scale/grade pay being drawn by such employee shall be protected on absorption as a measure personal and the difference need not be added in pay in the

pay band. The condition No.3 of the above referred O.M. may be deemed to have been modified to this extent.

This may kindly be brought to the notice of all concerned for strict compliance.
