Sir,

I am directed to convey the sanction of President of India to the expenditure of Rs.54,56,400/- (Rupees Fifty Four Lakh Fifty Six Thousand and Four Hundred Only) and release of Rs.27,28,200/- (Rupees Twenty Seven Lakh Twenty Eight Thousand and Two Hundred Only) (50% of Rs.54,56,400/-) as the 1<sup>st</sup> installment of the grant-in-aid for creation of barrier free environment in the building of Public Service Commission, Nigam Vihar at Shimla at Himachal Pradesh under the Accessible India Campaign (AIC) during 2018-19.

- 2. It is requested that arrangement may kindly be made to credit this amount in the Bank Account of the Government of Himachal Pradesh, in accordance with the procedure laid down in the Ministry of Finance O.M. 2(45)76-Spl.Cell dated 30.05.76 as modified vide their O.M. of even number dated 16.09.76, under information to this Section.
- 3. <u>Purpose for which this grant is sanctioned:</u> Creation of barrier free environment in the building of Public Service Commission, Nigam Vihar at Shimla in Himachal Pradesh for the PwDs, under the Accessible India Campaign (AIC) during 2018-19.
- 4. <u>Name of the Scheme:</u> Scheme arising out of Implementation of the Rights of Persons with Disabilities Act, 2016 (SIPDA).
- 5. Certified that this sanction has been noted at Sl. No. <u>12</u> in Register of Grants (maintained in Form GFR-21).

- 6. The Grant-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR) 2017. The Grants-in-aid is also subject to the Chapter 9 of the General Financial Rules 2017 as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions: -
- i) Certified that the pattern of assistance of rules governing such grants-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.
- ii) The accounts of the Government of Himachal Pradesh shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.
- iii) The Accounts of the Government of Himachal Pradesh shall be open for inspection by the Sanctioning Authority and Audit, both by any other Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.
- iv) Grants-in-aid to the Government of Himachal Pradesh are subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.
  - (a) The State Government of Himachal Pradesh shall submit the final Utilization Certificate for the entire grant along with a project completion report within three months after completion of the work/project as stipulated in the proposal. Unutilized money, if any, is to be refunded to the Ministry. In case the work/project is not completed within the stipulated timeframe and further time is sought to complete the same, the organization concerned has to intimate the Ministry and also explain the reason for the delay. If the project is not completed within the timeframe/extended timeframe, the organization concerned has to refund the grant forthwith.
  - (b) The Government of Himachal Pradesh shall furnish to this Ministry quarterly progress report on the project indicating both physical and financial achievements in relation to the approved project.
  - (c) The work has to be allotted as per terms and conditions laid down in General Financial Rules (GFR, 2017) /Codal Procedure/CVC Guidelines in the matters of contract/financial transactions.
  - (d) The State Government of Himachal Pradesh will prominently display details of grant-inaid received, purpose thereof, events organized and list of beneficiaries, wherever applicable on their Website.
  - (e) The Government of Himachal Pradesh will submit physical & financial progress report within one month & completion of the Project.

- v) The Government of Himachal Pradesh will confirm that the conditions mentioned in the letter are acceptable to them. The Government of Himachal Pradesh is exempted from executing the bond, to the Government of India.
- 7. The Government of Himachal Pradesh will follow the procedure of E-procurement for the project.
- 8. The Government of Himachal Pradesh will also follow Monthly expenditure plan. The Government of Himachal Pradesh shall inform immediately about the time frame of the Project.
- 9. Compliance of GFR norms and AIC norms mentioned in the SIPDA Scheme.
- 10. Certified that the present sanction/expenditure is covered under MEP for the month of May 2018 and Integrated Finance Division (IFD) has approved the expenditure during the 1<sup>st</sup> quarter of the financial year 2018-19.
- 11. The requirements of production of Utilization Certificate in respect of the grants to be sanctioned by the Government of India should be fulfilled to the satisfaction of the Government. The Government of Himachal Pradesh shall utilize the grant-in-aid in a timely and productive manner and they will furnish Utilization Certificate (UC) within one year from the date of issue of this sanction order.
