- The release is subjected to the following terms and conditions:-4.
  - Funds disbursement/transfer under the scheme will be made through the Public (i) Financial Management System (PFMS).
  - Funds shall be utilized only for the purpose for which it is released. (ii)
  - Utilization Certificate in the prescribed form GFR-12C alongwith audited statement (iii) of accounts should be furnished to the Ministry of Skill Development & Entrepreneurship, GOI as per General Financial Rules (GFR) 2017.
  - Unspent amount, if any will be adjusted against sanctions/reimbursements. (iv)
  - The expenditure shall not exceed the budget allocated. (v)
  - The norms and guidelines of All India Council for Technical Education (AICTE) are (vi) followed in the establishment of polytechnic, admission, and fee structure and also for teaching and non-teaching staff.
  - At the end of the financial year State Government shall have the accounts in respect (vii) of grants received from the Government of India audited through the concerned AG and submit audited statement of accounts to the Ministry of Skill Development and Entrepreneurship promptly along with the statement of physical achievements made during the year. The grants in aid in the subsequent years shall be released on receipt of the audited statement of accounts along with the progress report of the physical achievements. The State Government shall utilize the grants within twelve months of the date of sanction.
  - A total of Rs. 12.30 crore per district per polytechnic will be released in (viii) installments. Out of which, Rs. 8.00 crore will be spent on Civil Works and Rs. 4.30 crore will be spent on equipment, machinery, furniture, Transport and Learning Resource Materials. Any additional requirement of funds over and above the ceiling of Rs. 12.30 crore will be met by the State Govt.
  - The land alongwith the development charges as well as 100% recurring expenditure will be borne by the State Government.
  - The sanctioned strength of the teachers in the polytechnics has to be filled up and (x) in no case the vacancies should be allowed to exceed 5% of the sanctioned strength.
  - Semester system may be introduced for teaching and examining the students in all (xi) the existing as well as new polytechnics
  - Regular up-gradation of Syllabi keeping in view the demands of industry and (xii) employability of the students.
  - Evaluation/ feedback of teaching. (xiii)
  - Provision of broadband connectivity. (xiv)
  - The emphasis should be given to enhance hardware courses in electronic and (xv) electrical disciplines.
  - The admissions in these polytechnics shall be made by the respective State (xvi) Governments alongwith the other polytechnics of the States as per admission procedure criteria, reservation norms and guidelines followed.
