Subject: Release of funds to Govt. of Himachal Pradesh in respect of Solid Waste Management projects during 2016-17 under Swachh Bharat Mission (Urban)

Sir,

I am directed to convey the sanction of competent authority for payment of **₹1,78,00,000/- (Rupees One crore seventy eight lakh only)** in addition to ₹4,32,00,000/- released vide sanction letter dated 13.05.2016 to Govt. of Himachal Pradesh as Govt. of India share of Grant/VGF towards **implementation of solid waste management projects during 2016-17** under Swachh Bharat Mission (Urban) of the Ministry of Urban Development.

2. The sanction will be regulated in accordance with the provisions of GFR, 2005.
3. The expenditure is debitable to Major Head 3601 – Urban Development (Plan) – 04 – Grants for Centrally Sponsored Plan Schemes – 314 - Sewerage & Sanitation - Sanitation Service – 03 – Swachh Bharat Mission – 03 – Solid Waste Management – 35 - Grants for creation of Capital Assets under Demand No. 95 for the year 2016-17 of the Ministry of Urban Development.
4. The amount will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.
5. In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at www.moud.gov.in and following the same while releasing funds to the beneficiaries/ULBs, the release of funds for the Solid Waste Management Component will be restricted to and governed by the guidelines given in paragraph 7 of the SBM guidelines.
6. Entry has been made at Sl. No. 26 of Grant-in-aid Register for the year 2016-17.
7. No U.C. is pending for this project from Govt. of Himachal Pradesh.
8. This issues with the approval of Finance Division vide their Dy. No. 1062/IFD/2016 dated 16/06/2016.
