2. The grant-in-aid shall be subject to provision of GFR, 2017.
3. The state PMU shall be set up in accordance with the guidelines of the scheme issued by the Ministry of Tribal Affairs.
4. The Utilization Certificate for recurring grant will be submitted by the State Govt. to the Ministry as per Rule 239 of the GFR 2017 in Form GFR-12-C.
5. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned.
6. State Government shall ensure immediate transfer of funds to respective implementing agencies for setting up of PMU. Progress Reports of the grants released under the Scheme may be furnished. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR), 2017 amended from time to time.
