- The State Government shall furnish quarterly progress reports in respect of utilization of Special Central Assistance to the Government of India, Ministry of Social Justice & Empowerment within 15 days after the end of each quarter, in the prescribed Proforma sent vide this Ministry's letter No. 11014/18/97-SCD-II dated 11.5.2001.

- As per instructions contained in Ministry of Finance, Deptt. of Economic Affairs Circular No. F 2(23)-13 (CDN)/95 dated 10.2.1995 any unspent balance amount of previous year(s) cannot be carried forward for expenditure during the next financial year but will be adjusted against the amount of SCA due to State Governments/UT Administrations for the current year, at the time of release of final installment for the current year. The States/UTs have to ensure the full utilization of funds for the purpose for which it is given to them.
- The names and details of the assisted beneficiaries under the scheme may be displayed on the website of State Government/Department dealing with the development of Scheduled Castes.
- As per the instructions contained in Ministry of Finance, Department of Expenditure's Circular No. 7 (1) E. Coord/2008 dated 5.6.2008 no amount shall be released to any State which has defaulted in furnishing Utilizations Certificates for grants-in-aid released by the Central Government in the past.
- It is certified that no UC which is required prior to this release is pending against the 9. Government of Himachal Pradesh.
- The organization will maintain separate accounts in respect of the grants-in-aid received for this project. The accounts will remain open for inspection by the representatives or the officers from the Office of Comptroller and Auditor General of India/Government of India/concerned State Government at any time. The organization will have the accounts of the grant-in-aid audited either by the Govt. - The accounts will open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department whenever the Institution or Organization is called upon to do so.
