## Office Memorandum

Subject: - Mobility of personnel amongst State/Central & Autonomous Bodies while working under pensionable establishments.

The undersigned is directed to say that while introducing the Contributory Pension Scheme (also called New Pension Scheme) from 15.5.2003, amendment to Rule 2 of the CCS (Pension) Rules 1972 was made vide this Department Notification Fin (Pen) A (3)-1/96 dated 15.5.2003, whereby CCS (Pension) Rules 1972 were made inapplicable to all appointments made in the State Government of Himachal Pradesh, on or after 15.5.2003. Also, the new and changed position obtaining on mobility of personnel between State and Central Government/other State(s) Government departments; and between Government departments and Autonomous Bodies on technical resignation from 15.5.2003 under CCS(Pension) Rules was clarified vide O.M.No. Fin. (Pen) A (3)-1/2001 dated 13.9.2006.

- 2. The position has been further reviewed by the Government of Himachal Pradesh and it has been decided to continue mobility of Govt. servants/Autonomous body employees, appointed on or before 14.5.2003 and who were governed under the old non-contributory Pension Scheme of their respective Governments/organizations, in order to provide for the continuance of Pensionary benefits based on combined service, in accordance with CCS (Pension) Rules 1972 as under:-
  - (a) between State Government and Central / other State(s). Governments, provided the employees were appointed in the Central/other State Governments, on or before 14.5.2003 and covered under old pension scheme similar to CCS(Pension) Rules, 1972.

- (b) the pre-existing arrangement of mobility between State Government Department to Central Autonomous Bodies and Central Government Department to State Autonomous Bodies and between Autonomous Bodies that were governed by oid pension scheme in force up to 14.5.2003 vide Govt. of India O.M. No.28/10/84-P&PW.Vol-II dated 7.2.1986 adopted by State Govt. vide O.M. No. (C)A (3)-17/76-II 4.7.1986 and Govt. of India O.M. No.28/10/84-Pension Unit dated 29.8.1984 adopted vide O.M. No. Fin (Pen)A(3)-17/76-II dated 5.7.1996 stands restored, although, employees covered under Contributory Provident Fund (CPF) etc. will not be allowed entry into the CCS (Pension) Rules, 1972, on appointments from 15.5.2003.
- 3. These instructions modify/supersede the provisions contained in this department O.M No. Fin (Pen) A (3)-1/2001 dated 13.9.2006 to the extent as indicated above and take effect from 15.5.2003.
