Subject: - Restoration of full pension in respect of Govt. servants who had drawn lump-sum amount in lieu of pension on absorption in Public Sector Undertakings/Autonomous Bodies.

In partial modification of OM No. Fin (Pen) A (3)2/88 dated 11-2-1991, the State Government vide OM No. Fin(Pen)A(3)-2/88 dated 8th January, 1997 had decided that the benefit of restoration of 1/3rd commuted portion of pension after 15 years from the date of such commutation shall also be admissible to all those Govt. employees who had been absorbed in Public Sector Undertakings/ Autonomous Bodies/ Statutory Bodies etc., notwithstanding the fact that having commuted the full pension, they were not in receipt of any monthly pension.

2. Thereafter, instructions to revise restored amount of 1/3rd commuted portion of pension in respect of Govt. servants who had drawn lump-sum amount on their permanent absorption in Public Sector Undertakings and Autonomous Bodies w.e.f. 1-1-1986 and 1-1-1996 were issued vide Govt. OM No. Fin (Pen)A(3)-1/97-I, dated 4th June, 2005 and Office Memoranda of even number dated 3rd April, 2008 and dated 21st August, 2008 respectively. Further, instructions to revise the restored 1/3rd commuted portion of pension w.e.f. 1-1-2006 were issued vide office Memorandum No. Fin (Pen) A (3)-1/09-Part-III, dated 14-10-2009.



- 3. In order to give relief to such absorbee pensioners, the Governor, Himachal Pradesh is pleased to order that Government servants who had drawn 100% lump-sum amount in lieu of pension (1/3rd as well as 2/3rd) on their absorption in Public Sector Undertakings/Autonomous Bodies and in whose case 1/3rd pension has been restored, may be allowed restoration of full pension as per details in para-4 below.
- 4. The benefit of restoration of full pension shall be allowed from the prospective date i.e. from the date of publication of these instructions or completion of 20 years from the date of payment of 100% lump-sum amount, whichever is later.
- 5. All the concerned H.P. Government absorbees in Public Sector Undertakings/Autonomous Bodies etc. shall apply to the respective Administrative Department/ Office from where they had retired, for restoration of the full pension and the concerned Administrative Department/Office shall, after verification of claims from the relevant records, forward the papers to the Accountant General (A&E) Himachal Pradesh for authorization and to revise the Pension Payment Orders (PPOs) accordingly.
- 6. These order shall take effect from the date of publication in the Rajpatra (e- Gazette), Himachal Pradesh.
