

Short term Notice inviting Tenders/Rates for Star artists for Cultural Nights during National level Holi Utsav-2018 (27.2.2018 to 02.03.2018)

A notice is here by given to the Event Managers/Event Management Firms to quote rates of play back Singers, Laughter Artists, Punjabi, Sufi/Gazal Artists, Indian Idol/Sare-gama-Pa winners etc & submit on or before 15.02.2018 up to 12.30 PM. The Tenders/Rates will be opened in the Chamber of Additional Deputy Commissioner, Hamirpur at 01.00 PM on 15.02.2018. All the interested participants are requested to be present in person or through their representatives on the above said time, date and place. The terms and conditions shall be as under :-

1. The participants must have wide experience in the field and shall submit in brief the details of events conducted by him in last three year (2015, 2016 & 2017). They shall submit their PAN copy and Income Tax Returns. Tenders/ Rates of inexperienced participants are liable to be rejected.
2. All interested participants shall have to furnish a bank draft of Rs. 50,000/- in the name of Deputy Commissioner-cum-chairman Holi Utsav Committee, Hamirpur H.P.
3. A panel of Star artists shall be disclosed to all the participants and an hour shall be allowed for the confirmation of artists.
4. The lowest rates of each artist/performer shall be accepted, subject to the confirmation as mentions in Sr. No.3 and the condition mentioned at Sr. No.1.
5. The tendered/ party whose rates will be accepted shall have to execute an agreement with the Additional Deputy Commissioner Hamirpur to the effect that the artist/ performer shall be provided on the schedule date and time. On the failure to do so, the concerned party shall be liable to pay double the amount of that artist to the Utsav Committee as penalty and bank draft shall also stand forfeited.
6. The terms of payments shall be settled mutually by the Utsav Committee and Event Manager.
7. The DC cum Chairman National Level Holi Utsav reserves the right to reject any tender/ rates without assigning any reasons thereto.
