NOTIFICATION

In exercise of the powers conferred by provision to Article 309 of the Constitution of India, the Governor of Himachal Pradesh in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the Recruitment and Promotion Rules for the post of Chief Librarian Class, -II (Gazetted) in the Department of Personnel (Secretariat Administration), Himachal Pradesh as per Annexure "A" attached to this notification namely:-

Short Title and Commencement.

1. (1) These rules may be called the Himachal Pradesh Department of Personnel (Secretariat Administration Services) Chief Librarian (Class-II Gazetted) Recruitment & Promotion Rules, 1994.

(2) These rules shall come into force from the date of publication in the H.P. Gazette.

Repeal & Saving.

2. (1) The Recruitment and Promotion Rules for the post of Librarian (Class-II) (Gazetted) in the Department of Personnel Secretariat Administration Services) notified vide this Government Notification No. 118/94 S.A., dated 29th November, 1994 are hereby repealed.

12. In all cases of promotion, the service rendered in the feeder post upto 31.3.1991 if any prior to regular appointment to the post shall be taken into account towards the limit of service as prescribed in these rules for promotion subject to the condition.

 (1) that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis upto 31.3.1991) in the feeder post in view of the provisions referred to above all persons senior to him in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above, the junior person in the field of consideration. Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the Recruitment and promotion Rules for the post which exceeds loss.

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirement of preceding proviso, the person(s) junior shall also be deemed to be ineligible for consideration for such promotion.

EXPLANATIONS

The 1st proviso shall not render the junior incumbents ineligible for consideration for promotion if the senior ineligible persons happened to be ex-servicemen recruited under provisions of Rule-3 of Disabled Armed

Forces Personnel (Reservation of Vacancies in Himachal State Non-Technical Service) Rules-1972 and having been given the benefit of seniority or recruited under the provisions of Rule-3 of Ex-Servicemen (Reservation of Vacancies in the Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority thereunder:-

- (2) Similarly, in all cases of confirmation, service rendered on the feeder post upto 31.3.1991 if any, prior to the regular appointment against such post shall be taken into account towards the length of service.

Provided that inter-se-seniority shall be the result of confirmation after taking into account adhoc service rendered upto 31.3.1991 shall remain un-changed.

12. If a D.P.C. exists, D.P.C. to be presided over by the Chairman, Himachal Pradesh Public Service Commission or member thereof to be nominated by him.

13. Circumstances in which public service commission As required under the Rules

is to be consulted in making Recdt.

14. Essential Requirement for direct recruitment.

A candidate for appointment to any service or post must be :-

- (a) A citizen of India or
- (b) A subject of Nepal, or
- (c) A subject of Bhutan or
- (d) A Tibetan refugee who crossed over to India before the 1st January, 1962 with the intention of permanently settling in India.

- (e) A person of India origin who has migrated from Pakistan, Burma, Sri Lanka, East African Countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Malawi, Zaire and Ethiopia with the intention of permanently settling in India.

Provided that a candidate belonging to categories (a), (b), (c), (d) and (e) shall be a person in whose favour a certificate of eligibility

...has
has been issued by the Government of India.

A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or Interview conducted by the Himachal Pradesh Public Service Commission or other recruiting authority, but the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Government of India.

15. Selection for appointment to post by direct recruitment.

Selection for appointment to the post in the case of direct recruitment shall be made on the basis of viva-voce test; and if the Himachal Pradesh Public Service Commission or other recruiting authority, as the case may be, so consider necessary a practical test the standard, etc of which, will be determined by the Commission/ other recruiting authority as the case may be.

16. Reservation;

The appointment to this post shall be subject to orders regarding reservation in the services for Scheduled Caste/Scheduled Tribes Backward Classes other categories.

17. Departmental Examinations

(1) Every member of the service shall pass a Departmental Examination as prescribed in the Departmental Examination Rules, 1976 as amended from time to time, failing which he shall not be eligible to:-

- i) Cross the efficiency bar next due.
- ii) Confirmation in the service even after completion of probationary period and
- iii) Promotion to the next higher post.

Provided that an officer who has qualified the Departmental Examination in whole or in part prescribed under any rules before the notification of these rules, shall not be required to qualify the whole or in part of the examination as the case may be.

Provided further that an officer for whom no Departmental Examination was prescribed prior to the notification of these rules and who has attained the age of 45 years on the 1st March, 1976, shall not be required to qualify the Departmental Examination

prescribed under these rules.

Provided further that an Officer for whom no departmental examination was prescribed prior to the notification of these rules and who had not attained the age of 45 years on 1.3.1976 shall not be required to qualify the Departmental examination prescribed under these rules after attaining the age of 50 years for the purposes of :-

(i) Crossing the efficiency bar next due and (ii) Confirmation in the service after completion of probationary period.

(2) An Officer on promotion to the higher post in his direct line of promotion shall not be required to pass the aforesaid examination, if he has already passed the same in the higher gazetted post.

(3) The Government may in consultation with the U.P. Public Service Commission grant in exceptional circumstances for the reasons to be reduced to writing, exemption in accordance with Departmental Examination Rules, 1976.



(SA-IB)(2)-2/85-II.—In exercise of the powers conferred by Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with Himachal Pradesh Public Service Commission is pleased to make the following rules further to amend the Himachal Pradesh Department of Personnel (Secretariat Administration Services) Chief Librarian, Class-I (Gazetted) Recruitment and Promotion Rules, 1994, notified *vide* this department notification No. Per (SA-I) A (3)-3/85, dated 17.12.2003, namely :—

1. *Short title and commencement.*—(1) These rules may be called Himachal Pradesh Department of Personnel (Secretariat Administration Services), Chief Librarian, Class-I (Gazetted) Recruitment and Promotion (1st Amendment) Rules, 2003.

(2) These rules shall come into force from the date of publication in the Himachal Pradesh.
