

15. Agriculture Extension Office cum Residence at Pali is not being used by the department due to its dilapidated condition and building can be put to use after carrying out major repair.
16. Agriculture Extension Office cum Residence at Gadagusaini is lying vacant since a long time and building requires major repair.
17. Agriculture Extension Office cum Residence at shilibagi is not being used by the department due to its location which is 1 KM. away from road side and isolated condition of building is pathetic. Agriculture sale centre is running in rented building.
18. Agriculture Extension Office cum Residence at Ponta is not being used by the department due to its dilapidated condition and building requires heavy repair which can be put to use after carrying out major repair.
19. Agriculture Extension Office cum Residence at Bhaderwar is not being used by the department as the building is located in isolated place and not in use since long time which requires major repair.
20. Development Department old Quarter (0-4-18 bighas) at Urla JNR is lying vacant
21. Ayurved Deptt. old Quarter (0-1-10 bighas) at Urla is lying vacant
22. Gram Sewak Hut Serikothi Sundernagar is lying vacant as the same is damaged and not safe for use land can be used for other purpose
23. Gram Sewak Hut Kangu Sundernagar is lying vacant, as the same is damaged and not safe for use however, land can be used for other purpose
24. Gram Sewak Hut Dehar Sundernagar is lying vacant as the same is damaged and not safe for use but the land can be used for other purpose
25. Gram Sewak Hut Paurakothi Sundernagar is lying vacant as the same is damaged and not safe for use however, land can be used for other purpose
26. G.P.S. building at Ambedkar Nagar Sundernagar has been constructed under SBVSY and is lying vacant. Education Department is not taking over the possession of building after several request as reported by BDO Sundernagar.
27. Building of Leather Training Centre Industry Department at Sundernagar has been constructed by DRDA and is to be handed over to the Industry Department. As reported by BDO Sundernagar the E.O. (Ind.) is not taking over the possession of building the land has not been transferred either to Rural Department/Indst./Labour and employment department.

- 28. Forest Department's ACF Residence at Lalitchowk Sundernagar is not in use for want of repair.
- 29. Forest Department's Guard Hut at Jarol Sundernagar is not in use for want of repair.
- 30. Forest Department's Guard Hut at Trambri Sundernagar is not in use for want of repair.
- 31. Animal Husbandry Department's 6 No Quarters at Chauntra (01-14-15) lying vacant.
- 32. Animal Husbandry Department 4 No. buildings of Hatchery Farm alongwith quarters are lying vacant due to unsafe. The land 0-5-0 Bighas is available at Tikrimusher Jogindernagar.
- 33. 8 Rooms of Electricity Department at Jogindernagar due to its dilapidated condition are lying vacant and land 1129.0 Sq.Mtr. is available.
- 34. Newly constructed Tribal Hostel three storeyed (20- 25 rooms) at Bhatog Tehsil Sadar Sadar lying vacant for the last two years since its construction.
- 35. Building of Govt Primary School Balkpur at Karsog consisting three rooms is lying vacant due to transfer of School
- 36. Hostel building at Basa Gohar of Degree College is lying vacant for the last three years.
- 37. Hostel building of Govt Senior Secondary School Boys at Sarkaghat is lying vacant due to non living of student.
- 38. One Type-II Residence Building of Fisheries department at Bhararu Jogindernagar is lying vacant due to repair work for more than 5 years.
