NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 17th June, 2016 & 19th June, 2016 as public holiday in District Lahaul-Spiti & Chamba, Himachal Pradesh on account of general election of Panchayati Raj Institutions (in the areas of those PRIs, where the elections are scheduled to be held) on the respective dates (in case poll is held). All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops will remain closed on the said date in the areas of above Institutions. This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in above Panchayati Raj Institutions, on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.
