

अधिसूचना

हिमाचल प्रदेश के राज्यपाल, हिमाचल प्रदेश साधारण खण्ड अधिनियम, 1968 (1968 का 24) की धारा 20 के साथ पठित पुलिस अधिनियम, 1861 की धारा 46 की उपधारा (3) और हिमाचल प्रदेश पुलिस अधिनियम, 2007 (2007 का 17) की धारा 144 की उपधारा (2) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हिमाचल प्रदेश राज्य में यथा लागू पंजाब पुलिस रूलज, 1934 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

संक्षिप्त नाम और प्रारम्भ ।

- I. (1) इन नियमों का संक्षिप्त नाम पंजाब पुलिस (हिमाचल प्रदेश द्वितीय संशोधन) नियम, 2008 हैं।
- (2) ये नियम राजपत्र, हिमाचल प्रदेश में प्रकाशन की तारीख से प्रवृत्त होंगे।



In exercise of powers conferred by sub section (3) of section 46 of the Police Act, 1861 and Sub Section (2) of Section 144 of the Himachal Pradesh Police Act, 2007 (Act No. 17 of 2007) read with section 20 of Himachal Pradesh General Clauses Act, 1968 (Act No. 24 of 1968), the Governor of Himachal Pradesh is pleased to make the following rule further to amend the Punjab Police Rules, 1934 in their application to the State of Himachal Pradesh, namely:-

Short title and commencement: 1. (1) These rules may be called the Punjab Police (Himachal Pradesh 2nd Amendment) Rules, 2008

(2) These rules shall come into force from the date of their publication in the Rajpatra, Himachal Pradesh.

Amendment of rule 13.7

2. In the Punjab Police Rules, 1934 in their application to the State of Himachal Pradesh, in rule 13.7 in sub-rule (1) for the provision regarding "Written Test", the following shall be substituted namely:-
