In compliance of the judgment dated 03.08.2023 passed by Hon'ble High Court in CWP No. 2004 of 2017-titled as Taj Mohammad & Others Vs State of H.P. & Ors., the tentative seniority list of Commandants/Junior Staff Officers indicating the position as on 31.10.2024 was circulated vide this Department's Memorandum of even number dated: 13.11.2024. Representation/objection has been received from one officer Sh. Rach Pal Nepta within time period against the tentative seniority list. The objection raised by the officer have carefully been considered and it has been found that the seniority position of all the officers in the revised tentative seniority list has been assigned in compliance of the judgment dated 03.08.2023 passed by Hon'ble High Court in CWP No. 2004 of 2017-titled as Taj Mohammad & Others Vs State of H.P. & Ors. by counting their contractual service. Hence, the objection/claim made by the incumbent is not justified and same is hereby rejected.

Accordingly, the revised final seniority list of Commandants/Junior Staff Officers is hereby circulated as per Annexure-A for information of all the officers. No representation against this final seniority list will be entertained except clerical mistakes which will only be entertained within a period of 10 days from the date of issue of the seniority list.
