## OFFICE MEMORANDUM

Subject:-

Provisional seniority list of Deputy District Attorneys as on

31.12.2017.

Whereas the constitutional validity of the Rule 5(1) Demobilized Armed Forces Personnel (Reservation of Vacancies in the Himachal Pradesh State Non-Technical Service) Rules, 1972 which provide for counting of post service rendered by an ex-serviceman towards sonority was challenged by some Prosecutors in H.P. State Administrative Tribunal in O.A. No.191 of 1999. Said OA was dismissed/rejected by HPAT vide orders dated 12.1.2001. The Petitioners challenged these orders of HPAT alongwith seniority list of ADA as it stood on 1.7.1997 in Hon'ble High Court of H<sub>e</sub>P. in CWP No. 488 of 2001 titled as V.K. Behal and others Vs. State of H.P. and others which was allowed and finally decided by the Hon'ble High Court on 29.11.2008 with the following directions/observations:-

"In view of the above discussion, the writ petition is allowed. The Provision of Rule 5(1) of the Rules are read down and they are held to be unconstitutional in so far as they give benefit of counting the past army service towards sonority in civil employment in case of ex-servicemen who have not joined the Armed Forces during the period of emergency. It is also held that the benefit of such service cannot be give from the date prior to the date when the ex-serviceman attains the minimum educational eligibility criterion prescribed in the rules. Consequently, the sonority list Annexure P-3 is held to be illegal and is accordingly quashed and the respondents are directed to re-frame the same in accordance with the directions issued herein above."

 Whereas the above orders of Hon'ble High Court were challenged in Hon'ble Supreme court vide S.L.P. No 8710 of 2009 titled as R.K. Barwal Vs. State

- of H.P. and others. This SLP alongwith other similar SLPs was decided by Hon'ble Supreme Court on 25.8.2017 in Civil Appeal No. 011060 of 2017 (arising out of Special Leave Petition No. 8710 of 2009) . The Hon'ble Supreme Court vide its orders has uphold the judgment of Hon'ble High court dated 29.12.2008 delivered in CWP No.488 of 2001.
- 3. Whereas in compliance to orders of Hon'ble High/Supreme court of India seniority list of ADA as on 1.7.97 have been re-drawn and all DPCs convened thereafter for considering the eligible ADAs for promotion to the post of DDA have been reviewed by considering the ex-servicemen from the date of their actual dated of appointment/joining on the post of Asstt. Distt. Attorney.
- Whereas on the basis of recommendations of review DPC provisional sonority list of Deputy District Attorney as on 31.12.2017 has been drawn and is being attached herewith. The same is being circulated for inviting objections/representations, if any, with regard to their position shown therein within ten days from the date of issue of this memorandum. Objections/representations received after prescribed date will not be entertained and shall be deemed to have been rejected.
