**APPOINTMENT TO ONE POST OF MEMBER IN HIMACHAL PRADESH PRIVATE
EDUCATIONAL INSTITUTIONS REGULATORY COMMISSION, SHIMLA.**

1. Application(s) are invited for appointment to one vacant post of Member in Himachal Pradesh Private Educational Institutions Regulatory Commission, Shimla under the provisions of Section 4 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010. The Member shall be a person of eminence in public life or in the field of higher education or who have remained Secretary or above to the Government of Himachal Pradesh or held equivalent post in Government of India for a period of three years or more. The Member of the Commission shall be appointed by the State Government, on the recommendations of a Search Committee as per provisions contained in Section 4 of the Act *ibid*, for a period of three years or until he or she attains the age of 65 years, whichever is earlier, and such Member may be eligible for a second term subject to the upper age limit of 65 years. After the expiry of the term of office, the Member, as the case may be, shall be ineligible for further employment or any assignment in any of the Private Educational Institutions within Himachal Pradesh or their associate offices or companies within or outside Himachal Pradesh for a period of three years.
