No. 47-LSA/L.A.C.-Scheme/2003.— In exercise of the powers conferred by clause (g) of section 2 read with section 12 (g) of The Legal Services Authorities Act, 1987 (Act No. 39 of 1987), the Himachal Pradesh State Legal Services Authority hereby makes the following Scheme further to amend the Himachal Pradesh Legal Aid Counsel Scheme, 2003 notified vide this Authority Notification No.47-LSA/L.A.C. Scheme/2003-6891-7126, 7139-7141, 7145 & 7146, dated 22nd September 2003, published in the Rajpatra, Himachal Pradesh, dated 4th October, 2003, namely :—

1. Short title and commencement.— (i) This Scheme may be called the Himachal Pradesh Legal Aid Counsel (fourth amendment) Scheme, 2010.

(ii) It shall come into force with effect from **first day of June, 2017.**

2. Amendment of Para in 8 (i):— In Para 8 (i) the following shall be substituted:

- (i) For discharging his/her duties in the matters of legal aid, a Legal Aid Counsel shall be paid a consolidated fee of **Rs.5000/- per month at District level (District & Sessions Judge/ Addl. District & Sessions Judge/ Special Judge)** and **Rs.3000/- per month in other Courts.** The Legal Aid Counsel shall not receive any remuneration from accused in any form what so ever.
