
Establishment of Permanent Lok Adalat under Section 22-B of the Legal Services Authorities Act, 1987 at Una.

This issues with the prior concurrence of the Finance Department obtained vide their U.O.No.51264817-Fin-F/2008 dated 11.12.2009.


