  - iii) Bonafide Himachali Certificate.
  - iv) To produce minimum educational qualification certificate from H.P. Board/ other institution recognized by the Govt. of HP.
  - v) Character Certificate issued by the Executive Magistrate/ Gazetted Officer.
  - vi) Certificate signed by the Sub-Divisional Magistrate that they belongs to SC / ST / OBC, Category if any.
  - vii) He is required to furnish information in respect of his close relations and also furnish the information of assets and liabilities in the prescribed form duly completed alongwith declaration form on the date of his joining

- vii) He is required to furnish information in respect of his close relations and also furnish the information of assets and liabilities in the prescribed form duly completed alongwith declaration form on the date of his joining.
2. The post is temporary and purely on Daily Wage basis and his services are liable to be terminated at any time without assigning any reason. If he have to resign his post, he has to give one month's notice. Moreover, in case the work and conduct is not found satisfactory, his services is liable to be terminated without any notice
  3. The candidate will have to furnish a declaration to the effect that in case of his married status, he is having a one living spouse.
  4. The candidate will have to give an undertaking in writing that he was never convicted by any court of Law and if so, he will have to furnish details regarding offence committed and punishment thereof,. In case of concealing of facts his services are liable for termination.
  5. The candidate will have to take an oath of allegiance/ faithfulness to the constitution of India.
  6. He will be entitled leave etc. as per norms of Daily Wager.
  7. Provisions of service rules like FR/SR, Leave Rules, GPF Rules, Pension Rules and Conduct Rules etc. as are applicable in case of Regular Employees will not be applicable in case of Daily Wager appointees.
  8. Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of daily wager appointee and candidate shall not be entitled for remunerations for the period of absence from duty.
  9. The Daily Wager appointee will be eligible for transfer on need basis wherever required on administrative grounds.
  10. Daily Wager will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable on them by the Govt.
  11. He is liable to be transferred anywhere within the jurisdictions of the Department.
  12. His services are purely on contract basis and in case this work and conduct is not found satisfactory, his services is liable to be dispensed with without any notice.

If he is willing to accept the offer on the above terms and conditions, he should immediately report his self for duty at the place of posting as mentioned against their names within 15 days from the receipt of this letter failing which the offer shall stand withdrawn.
