Subject:- Grant of Maxi purchase permission All India, seating capacity 6 to 12+1.

Pursuant to the decision taken in the State Transport Authority meeting held on **24.02.2020** vide Agenda Item No. **2** on the applications received for the grant of contract carriage permit in respect of maxi cab (6+1 to 12+1), it is intimated that the applicants as per the list enclosed have been accorded sanction to purchase maxi cabs (6+1 to 12+1) with a **condition to register BS-IV vehicles before 31.03.2020** and to obtain contract carriage permit, on the following conditions:-

- 1. That the operator should produce a vehicle, which has a seating capacity up to 6 to 12+1 seats.
- 2. That the model purchased by the operator must be approved by the Department of Transport Himachal Pradesh.
- 3. As per orders of Hon'ble Supreme Court in Writ Petition (Civil) No. 13029 of 1985 dated 24th October, 2018 new vehicle conforming to emission Standard Bharat Stage-VI shall be <u>sold or registered in the</u> <u>entire country w.e.f. 01.04.2020</u>. So, owner of the vehicle may ensure registration of BS-IV vehicle before 31.03.2020 in all respect.
- Ministry of Road Transport and Highways letter No. RT-11016/16/2018-MVL dated 4th February, 2020 shall be complied with, before registering the vehicles.
- 5. While issuing grant letter to these operators an undertaking be obtained that they will not park their vehicles near the Bus stop /Taxi stand for passengers being used as Stage carriage. The vehicle will be parked at the complex of the Contract Agreement Agency.
- 6. Permit should be issued/restricted as per the period of Contract Agreement.
- 7. The vehicle will be used only to carry the passengers/Employees of the Contract agency. No other passenger allowed.
- 8. To discourage and stop illegal plying of contract carriage, all RTO's /ARTO's/MVI's will ensure that on front two doors of motor/maxi cab(6+1 to 12+1), permit holders should clearly mention in bold letters the name of the particular firm/organization/School etc. with which it is attached or is under contract agreement. In addition to above all other Contract Carriage Vehicles

- The vehicles to be attached with School/College/Universities etc. must be painted in yellow colour i.e. in accordance with the Hon'ble Supreme Court of India guidelines.
- 10. As per item No. 7 of the STA meeting held on 02/06/2018 the validity of grant letter so issued by you will be valid **for 9 months** only which can further be extended for 3 months by concerned Secretary, RTA level on payment of **Rs. 1000/-. After 12 months no grant letter shall be extended**.
- 11. Special care to be taken to register commercial vehicle on c/o address as it is noticed that tax recovery is difficult in cases of default in payments.
