### Terms and conditions: -

1. The sealed quotations shall be submitted by the Firms to the Director, Transport Department in a sealed envelope super scribed **“Quotation for the AMC of Weigh bridges”**. The sealed quotations, complete in all respects, must reach the office of the Director, Transport on or before **01-12-2017 by 11:00 AM** which shall be opened on the same date at 3.00 PM. The bidder or their authorised representatives may attend the meeting of opening of bid
2. The bidder shall quote rates for repair/civil work and AMC rates separately for each weigh bridge at barriers Parwanoo, Baddi, Barotiwala, Mehtpur, Gagret, Swarghat, Damtal and Tunuhatti Barriers. The L - I shall be determined on the basis of quotations received for AMC and rates quoted for all spare parts of weigh bridge. The bidder has to attach a list of all spare parts quoting therein rates.
3. The selected bidder shall have to do the service/visit barrier at least once in a quarter as a regular feature even if no complaint is received by them.
4. The bidder shall have to provide a warranty of one year for the parts replaced/job done after repair.
5. The bidder shall have to submit GST. Service Tax, Work contract registration certificate from the concerned authorities of State/Centre as applicable.
6. The bidder must have experience of 3 years in the relevant field of installation/repair of weigh bridge for which certificate is to be attached as a proof.

7. The bidder shall have to submit copies of PAN number, IT return filed and Balance sheets for the last three financial years duly certified by the Chartered Accountant.
8. The finally selected bidder shall have to submit a performance guarantee of 5% of contract value in the shape of FDR duly pledged in favour of Director, Transport, Himachal Pradesh for a period of one year.
9. The finally selected bidder shall also be required to supply the maintenance manual to Transport Department.
10. The rates shall be 'FIRM' and shall be quoted for each item separately. The rates so offered shall be inclusive of GST, service tax & any other local taxes/ levies etc.
11. The selected bidder shall be responsible for strict adherence of the provisions of Central/State Acts/Laws and regulations.
12. The contract may be terminated in any of the following contingencies:-
  - i) On the expiry of the contract period if not otherwise extended further.
  - ii) Giving notice of 15 days in case performance is not found satisfactory.
13. The contractor shall have to provide qualified and experienced technical staff on site of work in connection with the repair and maintenance of weigh bridges.
14. All repair and maintenance related complaints shall be attended to within 48 hours failing which a recovery of Rs.1000/- per day shall be made from the contractor.

15. Where the price quoted by the lowest bidder is highly excessive as compared to prevalent price justification, negotiation shall be held with lowest bidder to bring the price below justification. If the negotiation with lowest bidder fails to result in an acceptable contract, the Transport Department shall hold negotiation with the next ranked bidder & so on.
16. Contract shall be awarded to the lowest bidder subject to the condition as specified above.
17. The repair shall have to be completed within 15 days from the date of issue of the order.
18. The contract for AMC shall be initially valid for a period of one year but it can be extended for another year subject to satisfactory performance of the contractor which will be adjudged by the Director, Transport, Himachal Pradesh, Shimla on the basis of service provided/work done by the contractor concerned.
19. Any quotation inconsistent with the above terms & conditions shall be rejected straightway.'
20. The payment shall be made after 15 days of testing of Weigh Bridge after repair and verification of bill by the concerned authority. The payment of AMC shall be made as under:-
  - i). 80% in advance
  - ii). 20% after completion of contract period.
21. The Director, Transport reserves the right to reject any or all the quotations without assigning any reason.

22. The decision of the Transport Department on any disputes emerging out of the contract shall be final.

23. The dispute, if any, shall be subject to the jurisdiction of courts in Shimla.
