NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of Himachal Pradesh, in consultation with Himachal Pradesh Public Service Commission is pleased to make the following rules further to amend the Himachal Pradesh, Fisheries Department, Feed Mill Mechanic-cum-Operator, Class-III-(Non-Gazetted), Recruitment and Promotion, Rules, 1993 notified vide this Department Notification of even number dated 07.09.93, namely:-

- Short title and Commencement; 1(1)These rules may be called the Himachal Pradesh, Fisheries, Department, Feed Mill Mechanic -cum-Operator , ,Class-Ill(Non-Gazetted), Recruitment and Promotion(first amendment) Rules, 2011
 - (2) These rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

Amendment of Annexure-A: 2 In Annexure "A" to the Himachal Pradesh Fisheries Department, Feed Mill Mechanic-cum-Operator, Class-III-(Non-Gazetted), Recruitment and Promotion, Rules, 1993:-

(a) for the existing provisions against Col.No.4, the following shall be substituted, namely;

i) Pay scales for regular incumbents 5910-20200 Pay Band Grade Pay 1900 -

ii) Emoluments for contract employees Rs. 7810/-(As per details given in col. 15-A)

(b) for the existing provisions against Col.No.6, the following shall be substituted, namely:-Between 18 and 45 years.

(c) for the existing provisions against Col.No.10, the following shall be substituted, namely:-

100% by direct recruitment on regular basis or on contract basis as the case may be failing which transfer/deputation. The contract employees will get emoluments as given in Col. 15-A and will be governed by service conditions as specified in the said rules.



(d) for the existing provisions against Col.No.14, the following shall be substituted, namely:-

A candidate for appointment to any service or post must be 'a Citizen of India'.

(e) For the existing provisions against Col.No.15-A, the following shall be substituted, namely:-

Notwithstanding anything contained in these rules, contract appointments to the post will be made subject to the terms and conditions given below:-

(a) Under this policy, the Feed Mill Mechanic-cum-Operator in the Department of Fisheries, H.P. will be engaged on contract basis initially for one year, which may be extendable on year to year basis.

Provided that for extension /renewal of contract period on year to year basis the concerned HOD shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his period of contract is to be renewed/extended.

POST FALLS WITHIN THE PURVIEW OF HPSSSB:-(b)

The Director, Fisheries after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition with the concerned recruiting agency i.e. H.P. Subordinate Services Selection

The selection will be made in accordance with the eligibility conditions as prescribed in these Rules.

The Feed Mill Mechanic-cum-Operator on contract basis will be paid consolidated fixed contractual amount @ Rs 7810/- P.M.(which shall be equal to minimum of pay band+Grade pay). An amount of Rs 240/-(3% of the minimum of pay band + grade pay of the post) as annual increase in contractual emoluments for the subsequent year(s) will be allowed if contract is extended beyond one year.

APPOINTING /DISCIPLINARY AUTHORITY.

The Director, Fisheries Department Himachal Pradesh, will be appointing and disciplinary authority.

SELECTION PROCESS.

Selection for appointment to the post in the case of Contract Appointment will be made on the basis of viva-voce test or if considered necessary or expedient by a written test or practical test the standard/syllabus etc. of which will be determined by the concerned recruiting agency i.e. Himachal Pradēsh Subordinate Services Selection Board, Hamirpur.

(V) COMMITTEE FOR SELECTION OF CONTRACTUAL APPOINTMENTS:-

As may be constituted by the concerned recruiting agency i.e. the Himachal Pradesh Subordinate Services Selection Board, Hamirpur from time to time.

VI) AGREEMENT :

After selection of a candidate, he/she shall sign an agreement as per Annexure-B appended to these Rules.

(VII) TERMS AND CONDITIONS:

- (a) The contractual appointee will be paid fixed contractual amount @ Rs.7810/- per month(which shall be equal to minimum of the pay band + Grade Pay). The Contract Appointee will be entitled for increase in contractual amount @ Rs. 240/-(3% minimum of the Pay Band+ Grade Pay of the post) for further extended years and no other allied benefits such as senior/selection scales etc. shall be given.
- (b) The service of the Contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- (C) Contract Appointee will be entitled for one day casual leave after putting one month service. This leave can be accumulated upto one year. No. leave of any other kind is admissible to the contract appointee. He/she shall not be entitled for Medical Reimbursement and LTC etc. only maternity leave will be given as per Rules.
- (d) Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.



- (e) An official appointed on contract basis who have completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
- Selected candidate will have to submit a certificate of his/her fitness from a Government/ Registered Medical Practitioner. Women candidate pregnant beyond twelve weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined for the fitness from an authorized Medical officer/ Practitioner.
- Contract appointee will be entitled to TA/ DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart officials at the minimum of pay scale.
- (h) Provisions of service rules like FR SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled for emoluments etc. as detailed in this column.

No leave of any kind is admissible to the contractual appointee. He will not be entitled for Medical Reimbursement and LTC etc. Only maternity leave will be given as per Rules.
- Un-authorized absence from the duty without the approval of the controlling
 officer shall automatically lead to the termination of the contract. A contractual
 Feed Mill Mechanic-cum-Operator will not be entitled for contractual amount for
 the period of absence from duty.



- An official appointed on contract basis who have completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
- Selected candidate will have to submit a certificate of his/her fitness from a Government/Registered Medical Practitioner. In case of women candidates pregnant beyond twelve weeks will re0nder her temporarily unfit till the confinement is over. The women candidate should be re-examined for fitness from an authorized Medical Officer/Practitioner.
- Contract appointee shall be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counter-part Official at the minimum of the pay scale..
- The Employees Group Insurance Scheme as well as EPF/GPF will not be applicable to the contractual appointee(s).
