- 15. A candidate for appointment to any service or post must be:-
 - (a) A citizen of India, or (b) A subject of Nepal, Or
 - (c) a subject of Dhutan, Or (d) a Tibetean refugee who come over to India before the Ist January, 1962 with the intention of permanently setting in India, Or
 - (e) a person of Indian Origin, who hasmigrated from Pakistan Burma, Sri Lanka, Bast African countries of Kenya, Uganda, the United Republic of Tanzenia (Formerly Tanganike and Zanzibar) Zambia, Malawi, Zaire and Sthopia with the intention of permanently settling in India:

rrovided that a candidate belonging to categories (b) (c),(d) and (e) shall be a person in whose favour a certificate of eligibility has been issued by the Govt. of India/State Govt.

A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the Himachal Pradesh rublic Service Commission or other recruiting authority, but the offer of appointment shall be given only after the necessary eligibility certificate has been issued to him by the Govt. of India/Govt. of Himachal Fradesh.

- 16. Upper age limit for wirect recruits will not be applicable to the candidates already in service of the Govt.
- 17. Upper age-limit is relaxable for Sch. Castes/Sch. Tribe's candidates and certain other categories of persons to the extent permissible under the general or special orders of the Himachal Fradesh Govt.
- 18. Age limit for airect recruits will be reckoned from the last date fixed for receipt of applications/receipt of lists of eligible candidates from Employment Exchanges by the Commission.
- 19. age and experience for the direct recruits relaxable at the discretion of the Commission in the case of candidate otherwise well qualified.
- 20. Provisions of Columns 10 and 11 are to be revised by the Govt. in consultation with the Commission as and when the No. of posts under Column 2 is increased or decreased.
- 21. Selection for appointment to these posts in the case of direct recruitment shall be made on the basis of a Viva Voce test, if the Commission so consideres necessary expedient, by a written test, the standard/syllabus etc. or which will be determined by the Commission or a practical test.

22. In all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including adhece one rendered upto 31-42-83) in the feeder post, all persons senior to him in respective categories shall be deemed to be eligible for consideration and placed above the junior persons in the field of consideration.

rrovided that all incumbents to be considered for promotion/confirmation shall possess the minimum qualifying service of at least three years or that prescribed in the relevant recruitment and promotion rules for the post whichever is less.

revided further that where a person becomes in eligible to be considered for promotion/confirmation on account of the requirement prescribed in the preceding proviso, the person(s) junior to him shall also be deemed to be ineligible for consideration for such premotion/Confirmation.

- 23. The employees of all the rublic Sectors/Corporations and autonomous Bodies who happened to be Geut. Servants before absorbation in the rublic Sector/Corpor tion/autonomous Bodies at the time of initial constitution of such Corporation/autonomous Bodies shall be allowed age concession in airect recruitment as admissible to Govt. servants. This concession will not, however, be admissible to such staff of the rublic Sector/Corporations/augonomous Bodies who were/are subsequently appointed by such Corporations/autonomous Bodies who were/are subsequently appointed by such Corporations/autonomous Bodies and are/were finally absorbed in the service of such Corporations/autonomous Bodies after the initial constitution of the rublic Sector Corporations/autonomous Bodies.
- 24. The appointment to the service shall be subject to orders/ regarding reservation in the service for Sch. Castes/Sch. Tribes/Backward Classes etc. issued by the Himnohal requesh Govt. from time to time.
