3. The above appointment/promotion will be subject to the following terms & conditions:-

- (i) This promotion is subject to the provisions of the H.P. Administrative Service Rules, 1973, as amended from time to time.
- (ii) All the Officers shall have to pass the prescribed departmental examinations, in full, within two years from the date(s) of their regular promotion(s) to the service and in case any candidate fails so to pass the departmental examination, his/her name shall be removed from the service.
- (iii) All the Officers shall have to undergo the prescribed Professional/ Settlement Training in HPAS, within probation period.
- (iv) Only after completion of the period of probation prescribed under the HPAS Rules, 1973, the Officers shall be qualified for their substantive appointment in the service, provided they have passed the departmental examination and completed prescribed Professional/Settlement Training successfully in the HPAS.
- (v) The benefits of four tier pay scale(s) will only be given/released to these Officers, after passing of departmental examination and completion of Professional/Settlement Training and also as per instructions of the Finance Department, issued from time to time.
