In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following rules further to amend the Himachal Pradesh Administrative Service Rules, 1973, notified vide this Department's Notification No. 7-5/73-DP(Apptt.), Dated 15.03.1973 and published in the Rajpatra (Extra Ordinary) dated 11.05.1973, namely:-

Short title and commencement.	1. (1)	These rules may be called the Himachal Pradesh Administrative Service (Second Amendment), Rules, 2013.
	(2)	These rules shall come into force from the date of publication in Rajpatra, Himachal Pradesh.
