issue Other Backward Classes certificates shall be as under:


- i) District Magistrate/Additional District Magistrate/

Commissioner (Not below the rank of Ist Class
Stipendiary Magistrate).
- ii) Chief Presidency Magistrate/Additional Chief
Presidency Magistrate/ Presidency Magistrate.

- iii) Revenue Officer not below the rank of Tehsildar; and
- iv) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.
