Implementation of Constitution (85th Amendment) Act, 2001 and assignment of seniority to SC/ST Government servants on promotion by virtue of rule of reservation/roster.

Sir,

In continuation of this department's letter No. PER(AP)-C-F (1)-1/2009, dated 01.05.2010 on the subject cited above, I am directed to say that the matter regarding implementation of Constitution (85th Amendment) Act, 2001 in the State was under consideration of the Government for sometime past. In the meantime, an I.A. No. 6/2012 in Special Leave to Appeal (Civil) No. 30143/2009 was filed by the H.P. Scheduled Tribes Employees Federation & Anr. before the Hon'ble Supreme Court. The aforesaid I.A. appeared before the Hon'ble Apex Court on 06.09.2012 when the Hon'ble Apex Court directed the State Government to take necessary policy decision in the matter within a period of eight weeks from the date of receipt of a certified copy of order.

2. As per directions of the Hon'ble Apex Court while the matter was under consideration for decision of the Government, the Model Code of Conduct from 03.10.2012 to 24.12.2012 in connection with General Assembly Elections in

the State was enforced, due to which it was not possible to take the policy decision. Therefore, an application for extension of time till 31.01.2013 for compliance of the order, dated 06.09.2012 was moved by the State Government before the Hon'ble Apex Court which was granted.

3. The matter was considered at an appropriate level and after careful consideration, it has been decided that in view of on going process of Constitution (117th Amendment) Bill, 2012 in the Union Government, the matter regarding implementation of Constitution (85th Amendment) Act, 2001 in the State may be deferred and existing reservation system in promotions continued till the finalization of matter relating to Constitution (117th Amendment) Bill, 2012. However, the instructions issued pursuant to the interim order dated 07.01.2013 of the Hon'ble Apex Court in I.A. No. 6/2012 in Special Leave to Appeal (Civil) No. 30143/2009, vide letter No. PER(AP)-C-E (3)-2/2009-III, dated 11.01.2013 will continue in operation till further orders.
