3. All the candidates shall have to pass the prescribed departmental examinations, in full, within two years from the date(s) of their appointment(s) to the service and in case any candidate fails so to pass the departmental examination, his/her name can be removed from the service.
4. On completion of the period of probation prescribed under the rules, the candidates shall be qualified for their substantive appointment in the service provided they have passed the departmental examination and completed prescribed training successfully.
5. The offer(s) of appointment(s) are further subject to the verification of character and antecedents and if anything found unsatisfactory in the report, in that case services of the said candidate will be liable to be terminated immediately.
