Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that as per prevailing procedure, the transfers and postings of Class-IV employees is approved by the Hon'ble Chief Minister, H.P. during the ban period. The matter has been examined and it has been decided that henceforth the proposals for the transfer and posting in respect of Class-IV employees shall be approved by the concerned Minister-in-charge only. The transfer & posting of Class-IV employees may be ordered by strictly observing the following conditions:

- Transfer and posting should strictly be processed/approved in accordance with the Comprehensive Guiding Principles-2013 circulated vide this department O.M dated 10-07-2013,
- ii. The transfer of Class-IV employees shall be ordered in a fair, transparent and impartial manner to avoid hardship to them and resultant litigation, and
- iii. No transfer shall be approved / ordered where the tenure prescribed under the Comprehensive Guiding Principles–2013 ibid is not met with. However, in genuine circumstances, the same can be ordered after approval from the Minister-in-Charge in relaxation of norms relating to stay at one place by recording reasons.
