Dear Member of Service,

It may be recalled that an application, namely, SPARROW, was introduced w.e.f 1st April, 2014 for online filing of PAR by IAS officers. The PAR had to be authenticated by all the officers through Digital Signature Certificate(DSC). As DSC was required for filing PAR on-line, the fee related to it was exempted and NIC was requested to issue DSC to the officers through their authorized Centres. While majority of the officers have been provided DSCs, the newly recruited and few other officers did not get the DSC. Meanwhile, due to some technical reasons NIC have suspended issuing DSC for the time being. On the request of DOPT, an arrangement has been made with (n)Code, a division of Gujarat Narmada Valley Fertilizers & Chemicals Ltd. to provide DSC to officers/functionaries associated with SPARROW to the remaining officers.

- 2. A copy of the registration form for issue of DSC is enclosed. The form contains details about the subscriber viz. (a)Name; (b)e-mail ID;(c)Date of Birth; (d)Organization's name; (e)Address; (f)Town/City/District; (g)State/Union Territory; (h)PIN; (i)Name of the Govt. Orgn/Agency/Dept. etc. These fields constitute "Distinguished Name" of the subscriber which are unique on the internet. In case, there is change in any one of the above mentioned fields after getting DSC, then the DSC would have to be revoked and subscriber would be required to apply afresh. In order to ensure that the DSC once issued to the IAS officer remains with him/her till he/she is in service, the following generic values against the following fields are to be filled in the form:
 - (i) In the column for the 'Organization Name' the officer has to indicate 'DOPT' irrespective of the place of posting; and
 - (ii) in the column for 'Town/City/District' the officer has to indicate 'New Delhi-110001'.
- 3. The form along with the passport size photograph duly signed by the applicant would have to be verified by the GAD Department of the respective State Government/JS(Admn.) of the Department at the Centre. For issue of DSC, there is a fee. However, State Govt./Department at the Centre or Member of Service (MOS) is not required to pay this amount as this would be taken care of by the NIC.
- 4. (n)Code is having 6 centres across the country. The details of these Centres including the City in which they are located, Contact Person, Contact details, email ID etc. are enclosed herewith. The registration form can be submitted at any of these centres and (n)Code has assured that DSC would be made available within a week's time from the date of receipt of form complete in all respects.
