Provided that if the Chairman or a Member, at the time of appointment as such is a person retired from Government, a local Body, a University or any other Body wholly or substantially owned or controlled by the Government and was drawing pay more than the maximum of the pay scales of Chairman and Member in that case the last pay drawn by them shall be taken into consideration for fixation of pay subject to the condition that pay plus gross pension shall not exceed ₹80,000/- per month.”.

NOTIFICATION

In exercise of the powers conferred by clause (a) of Article 318 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following Regulations further to amend of the Himachal Pradesh Public Service Commission (Members) Regulations, 1974 notified vide Notification No. 8-3/72-DP (Apptt.II), dated 15-5-1974 and published in the Rajpatra, Himachal Pradesh on 10th August, 1974, namely :-

Short title and Commencement.	1.	(1)	These Regulations may be called the Himachal Pradesh Public Service Commission (Members) (Twenty forth Amendment) Regulations, 2015.
		(2)	These Regulations shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.
Amendment of Regulation 5.	2.		For the existing Regulation 5 of the Himachal Pradesh Public Service Commission (Members) Regulations, 1974, the following shall be substituted, namely:- “5. The Chairman and Members appointed to Commission shall receive pay and allowances as admissible to the Chief Secretary and Principal Secretary respectively under the State Government from time to time.”
Amendment of Regulation 9.	3.		For the existing Regulation 9(2) of the Himachal Pradesh Public Service Commission (Members) Regulations, 1974, the following shall be substituted, namely:- contd...2...


