Subject: - Regarding fifty percent batch-wise recruitment to posts where the candidates have undergone professional training.

Sir,

No. PER (AP)-C-(B)2-1/98, dated 21-4-1998, 2-12-1998 and 17-1-2008, on the subject noted above and to say that as per policy decision of the State Government, in all cases where candidates have undergone professional training, 50% recruitment to such posts is made on batch-wise basis. This policy decision is also applicable in some Class-I posts in the cadres of Engineers and Doctors in Health & Family Welfare, Ayurveda and Animal Husbandry departments. Resultantly, suitable provisions for making 50% recruitment on batch-wise basis are incorporated in the Recruitment and Promotion Rules of respective categories/posts.

2. The matter to keep away all Class-I posts out of the purview of 50% recruitment on batch-wise basis was under consideration of the Government for some time past. After careful consideration, it has now been decided that there will be no batch-wise recruitment in any Class-I service in the State.
