"By promotion from amongst the Personal Assistant(s) possessing 05 (five) years' regular service or regular combined with continuous adhoc service, if any, in the grade, failing which by promotion from amongst the Personal Assistant(s) possessing 14 (fourteen) years' regular service or regular combined with continuous adhoc service, if any, as Personal Assistant & Senior Scale Stenographer combined which shall also include 02 (two) years essential service as Personal Assistant, failing both by promotion from amongst the Personal Assistant(s) possessing 19 (nineteen) years' regular service or regular combined with continuous adhoc service, if any, as Personal Assistant, Senior Scale Stenographer & Junior Scale Stenographer combined which shall also include 02 (two) years essential service

as Personal Assistant, failing all by promotion from amongst the Personal Assistant(s) possessing 24 (twenty four) years' regular service or regular combined with continuous adhoc service, if any, as Personal Assistant, Senior Scale Stenographer, Junior Scale Stenographer & Steno Typist combined which shall also include 02 (two) years essential service as Personal Assistant".
