Regarding non-discrimination of disabled persons in Government Employment -- Instructions thereof.

Sir,

"Jai Hind"

I am directed to say that the Government of India has enacted "THE PERSONS WITH DISABILITIES (EQUAL OPPORTUNITIES, PROTECTION OF RIGHTS AND FULL PARTICIPATION) ACT, 1995," 1996, on 1st January, 1996 which has been extended to the whole of India except the State of Jammu and Kashmir. It is mandatory to implement its sections in letter and spirit. Section 47 of this Act is related to non-discrimination of disabled persons in Government employment, an extract of which is reproduced as under:-

> "47,(1) No establishment shall dispense with or reduce in rank, an employee who acquires a disability during his service:

Provided that, if an employee, after acquiring disability is not suitable for the post he was holding, could be shifted to some other post with the same pay scale and service benefits:

Provided further that if it is not possible to adjust the employee against any post, he may be kept on a supernumerary post until a suitable post is available or he attains the age of superannuation, whichever is earlier.

(2) No promotion shall be denied to a person merely on the ground of his disability:

Provided that the appropriate Government may, having regard to the type of work carried on in any establishment, by notification and subject to such conditions, as may be specified in such notification, exempt any establishment from the provision of this section."

- 2. Accordingly, the State Government has decided to follow the above referred to provisions of section 47 of the Act in toto. You are, therefore, requested kindly to adhere to these provisions of the Act in letter and spirit.
- 3. These instructions may kindly be brought to the notice of all concerned for strict compliance.
