I am directed to invite a reference to this Department letter No. Per(AP-II)B(17)2/76 dated 8.05.1978 (Annexure 25.4 of Hand Book on Personnel Matters Vol.II) on the subject cited above which envisages that representations relating to service matters of employees should be disposed of on priority and must be decided finally within a period of two months. It has come to the notice of the Government that these instructions are not being complied with strictly, which is giving rise to representations to higher authorities/Ministers as also avoidable litigation in various Courts/Tribunals. This matter has been considered at Govt. level and it has been decided to frame grievance redressal mechanism at all levels of the Govt., i.e., at the level of Secretary, Head of Department, Zonal, Divisional, District and Sub-divisional level, where the representations of Govt. employees on service matters will be processed on priority and decided finally within 2 months by passing a speaking and reasoned orders by the authorities competent to decide such matters as per relevant rules/instructions.

These instructions may please be adhered to in letter and spirit and action taken in the matter may be intimated to this Department at an early date.
