NOTIFICATION

The Governor, Himachal Pradesh, on the recommendations of the Departmental Promotion Committee which was held on 19-6-2012 in pursuance to the orders passed by the Hon'ble H.P. High Court in CWP No. 9828/2011 titled as Champa Chauhan Vs. State of H.P. & ors., is pleased to order the promotion of Sh. Bhoop Ram Verma, Private Secretary of H.P.
