Subject: - Providing of reservation to the disabled persons in
respect of Class- I to IV posts/services to be filled in by
direct recruitment ---Instructions thereto regarding.

Sir,

I am directed to invite your kind attention to the
instructions issued by the Govt. vide this Department's letter No. PER.
(AP)-C-B (12)-1/2005, dated the 16th January, 2006 on the subject noted
above and to say that it has come to the notice of Government that in some
cases, totally blind suitable persons are not becoming available against the
posts reserved for them. Hence, the posts reserved for such totally blind
persons cannot be filled up from the available suitable low vision disabled
persons.

2. In order to meet with this eventuality, it has now been
decided by the Government that henceforth, in the event of non-availability
of totally blind suitable disabled persons against the posts reserved for them,
then such reserved posts may be filled up/given to the available suitable low

vision disabled persons, provided they fulfil the low vision percentage criterion fixed for the purpose, subject to the condition that this reservation will be given to them out of their own 1% quota i.e. their total percentage of reservation in services shall not exceed the limit of 1% reservation distributed to this category of disabled persons.

3. These instructions may please be followed strictly and also brought to the notice of all concerned for compliance.
