Subject:- Reservation roster – Post based – Implementation of Supreme Court Judgement in the case of R.K. Sabharwal Vs. State of Punjab and enhancement of reservation in services for Other Backward Classes.

Sir,

I am directed to refer to this department's letter No. PER. (AP)-C-B(12)-1/98, dated 20.08.1998 on the subject cited above and to say that the Government has provided 15% reservation to Antodaya/I.R.D.P. in the services of the State in direct recruitment to Class-III & IV posts. The proposals for clarification regarding validity of I.R.D.P. or B.P.L. certificates with regard to reservation in services of the State have been inviting attention of the Government.

2. The clarificatory instructions issued by the Rural Development Department vide their letter No.SMJ-6/2002-R.D.D.-V-526-50, dated the 23<sup>rd</sup> October, 2008 reveals that prior to 1999 families were identified under

I.R.D.P. scheme and thereafter I.R.D.P. certificates were used to be issued. In the present context, the B.P.L. certificates are being issued instead of I.R.D.P. certificates and there is no provision to issue IRDP certificates now.

3. In the wake of above narration, the B.P.L. certificates are being issued instead of I.R.D.P. certificates and there is no provision to issue the I.R.D.P. certificates at present. As such, the words "I.R.D.P." in the First Appendix to Annexure-"C" of the instructions dated 20.8.98 as referred to above are substituted with the words "B.P.L." and the above mentioned instructions dated 20.08.1998 may be deemed to have been amended to this extent.

4. These instructions may kindly be brought to the notice of all concerned for strict compliance.
