2001 and assignment of seniority to SC/ST Government
servants on promotion by virtue of rule of
reservation/roster.

Sir,

I am directed to invite your kind attention to the instructions issued by the Government vide Department of Personnel letter No. PER. (AP)-C-F (1)-1/2005, dated the 7th September, 2007 on the subject noted above and to say that the Himachal Pradesh Samanaya Varg Karamchhari Kalyan Mahasani, above Quality Sweet Shop, Kasumpti Bazar, Shimla-9 through its President has filed an O.A. No.19/2008 against these instructions in the Hon'ble H.P. Administrative Tribunal, Shimla, which was listed before the Hon'ble Tribunal on 4-01-2008, when the Hon'ble Tribunal was pleased to direct the respondent State to maintain status quo as on 4-01-2008 qua implementation of instructions, dated the 7th September, 2007. An application was filed by the respondent State on 8-01-2008 before

the Tribunal for extension of one month's time for filing reply in the matter and the Tribunal granted extension in time on 8-01-2008 with further order that the status quo order passed on 4-01-2008 is extended till the next date of hearing. In the meanwhile, another three M.A.s were also filed before the Hon'ble Tribunal for impleading them as respondents in the said O.A. No.19/2008, which came for hearing on 11-01-2008 when the Hon'ble Tribunal inter alia was pleased to pass further order that in addition to status quo order passed on 4-01-2008, which is extended till the next date of hearing, all promotions made since 4-01-2008 i.e. after the status quo order will be subject to final out come of this original application.

2. In view of the above orders of the Hon'ble Administrative Tribunal, that status quo qua implementation of the instructions, dated the 7th September, 2007 be maintained till further orders, therefore, it is stressed upon all concerned that the orders of status quo passed by the Hon'ble Tribunal in the instant case may be adhered to in letter and spirit.

7. These instructions may kindly be followed and also brought to the notice of all concerned for strict compliance.
