Liaison Officers for work relating to reservation for Scheduled Castes and Scheduled Tribes in services--- Information thereto regarding.

Sir,

I am directed to say that the Hon'ble Welfare Committee has conducted oral examination of the Secretary (Pers.) to H.P. Govt. on 18.10.2002 on the issue regarding reservation roster and fulfilment of reserved posts. The Committee, among other issues, has pointed out that some of the Departments/Boards/Corps. etc. have not nominated/appointed the Liaison Officers so far and this omission has been viewed very seriously by the said Committee.

2. In this regard, your kind attention is invited to the instructions issued by the Government vide Department of Personnel letter No.PER.(AP)-C-F(4)-7/99, dated the 23rd October, 2000 vide which the instructions issued by the Government vide letter No.8-61/71-DP(AP-II), dated 17th December, 1973 were reiterated. It was also emphasized upon all that the instructions, dated the 17th December, 1973 may be followed strictly and any departure from these instructions would be viewed seriously by the Government.

3. In view of the above narration, it is once again

emphasized upon all concerned to follow the above referred to instructions, dated 17th December, 1973 in letter and spirit. All such departments/Boards/Corps./University(ies) who have not nominated / appointed the Liaison Officer as yet, may also do the needful without any further delay.

4. Further, it is requested to send the information regarding the name of the Liaison Officer nominated/appointed by the Department / Board / Corp. etc. for the purpose with his / her designation on the enclosed proforma within seven days so as to enable us to send the consolidated information to the Hon'ble Welfare Committee accordingly.

4. This may kindly be given your personal attention and "Top-Priority" being a time-bound Vidhan Sabha matter.
