Age: The applicants must be above the age of 18 years and below 35 years as on the last date of receipt/ submission of applications.

## **Terms & Conditions**

- 1. The applicants must be bonafide residents of Himachal Pradesh.
- 2. The selection shall be made on the basis of viva-voce and in case the number of applicants exceeds more than five times the number of vacancies, a screening/written test shall also be conducted and the short-listed candidates shall thereafter be called for viva-voce. The final merit of the candidates shall be drawn accordingly. A Selection Committee shall be constituted by the Managing Director of the HPSIDC for the purpose of selection to the above posts. The decision of the Managing Director shall be final and binding with regard to selection of suitable candidate(s) for the ibid posts.
- 3. The contractual appointment shall initially be for a period of one year which may be renewed on a yearly basis at the discretion of the Corporation.
- 4. The incumbent(s) selected shall execute an agreement/contract deed as may be prescribed by the Corporation. The detailed terms & conditions of appointment shall be specified in the said agreement/contract deed.
- 5. The incumbents shall have no right to claim regularization/permanent absorption as such in the Corporation at any stage during the course of employment.
