

Selection of Candidates for The Post of Patwaris in the Districts in H.P.

Applications are invited from the eligible candidates of Himachal Pradesh on or before **4.6.2016** for selection of candidates for the post of Patwaris who will be appointed on the terms and conditions of Govt. of Himachal Pradesh on contract basis after qualifying the examination after successful completion of training.

1. Essential Educational Qualification

- (a) Candidates should have passed 10+2 examination or its equivalent from a recognized Board of School Education/University.
- (b) The candidates appearing in sports category should be National level medal winner or who have participated three time in National level tournament.
- (c) Candidates belonging to reserved category shall have to submit proof that he belongs to reserved category (to be attached with application form)
- (d) Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

2. **Age** Between 18 and 45 years. (Upper Age limit for reserved category candidates will be relaxable as per Govt. Rules..)
