TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLES.

1. The Resident Commissioner, Government of Himachal Pradesh, Himachal Bhawan, 27-Sikandra Road, Mandi House, New Delhi-01 intends to dispose of condemned vehicles on "as is where is basis".
 2. Interested Parties may submit their highest Prices for the condemned items as mentioned in auction notice in sealed covers latest by 11:00AM on or before 30.09.2024. The inner cover containing quotations and other relevant documents alongwith demand draft towards earnest money should be sealed properly. Sealed quotations may be submitted in the office of Resident Commissioner, Government of Himachal Pradesh, New Delh-01. Both the inner and outer covers should be superscribed in bold letters "Quotations for vehicles No.
 3. The Disposal of vehicles shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Department. The condition of the vehicle can be inspected physically at Resident Commissioner Office, Government of Himachal Pradesh, New Delhi-01 on any working day during office hours.
 4. The Quotation should be accompanied by earnest money for Rs.50000/- for the vehicles in the form of Bank Demand Draft only in favour of Resident Commissioner Office, Government of Himachal Pradesh, New Delhi. The highest bidder will be required to pay the entire amount on the spot in cash/Bank Draft. The successful bidder shall remove the vehicles from the site within 02(Two) days from the date of acceptance of the bid.
 5. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Addhar Card/Voter Identity Card/ Pan Card) in case of individual and registration Certificate in case of firms etc.
 6. The successful bidder(s) will also be responsible for getting the Registration Certificate of the vehicle(s) transferred in his /her name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
 7. The present registration number of the vehicles shall be retained by the GAD and not be transferred to the bidder. The highest bidder/the bidder who has been awarded the bid shall have to apply for new registration number for the vehicles as per the due procedure and process under the rules Motor Vehicles Act,1988 at his cost only.

8. The Resident Commissioner, Government of Himachal Pradesh, New Delhi reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
9. Earnest money Demand Draft of unsuccessful bidders shall be returned within two weeks of auction of the vehicles.
10. The bidders are required to reveal their full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
11. Disputes, if any, shall be subject to jurisdiction in the Court of Shimla only.
12. If the highest quoting firm fails to honour the bid: the bid will be cancelled & its EMD will be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder (H-2quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1party. In case of any dispute, decision of the Resident Commissioner, Govt. of HP., shall be final.
