| Subject: | Grant of Interim Relief to the Pensioners of the Govt. of H.P. w.e.f. 1-11-2006. |

The undersigned is directed to invite a reference to Finance Department O.M. No. Fin(PR)B(7)-2/2006- dated 7-3-2008 on the subject cited above vide which Interim Relief @5% of pay (including Dearness Pay) has been granted w.e.f. 1-11-2006 to the employees of Government of Himachal Pradesh.

2. The interim relief is to be treated as pay for the purposes of payment of Dearness Allowance and retirement benefits as per provision of aforesaid Office Memorandum.

3. To ensure that the Government servants retiring between 1-11-2006 and 31-8-2007 do not face any loss in fixation of pension, as a special dispensation in their case, the Governor, Himachal Pradesh is pleased to decide that Interim Relief @5% of Pay Plus Dearness Pay would be treated as basic pay only for calculation of average emoluments for the purpose of computation of pension, in respect of basic pay received by them prior to 1-11-2006.

4. Since 5% Interim Relief is counted for calculation of retirement benefits, therefore, Pension/Family Pension shall be calculated at @ 50% and 30% respectively of Pay plus Dearness Pay Plus 5% Interim Relief, subject to the minimum of Rs.2063 and maximum of 50% and 30% of the pay plus dearness pay plus 5 % Interim Relief subject to pension ceiling of Rs.19,500/- and family pension ceiling of Rs.11,700/-, respectively. The provisions contained in para 8 and 10(i) of this Department O.M.Fin (Pen)A(3)-1/96-II Part-I dated 31.8.1998 and O.M.No.Fin(Pen)B(10)6/98-I dated 8.8.2005, will therefore stand amended to that extent.

The Heads of Department / Heads of Offices shall submit the cases to the Accountant General (A&E), Himachal Pradesh for revision of pension where Pension / Family Pension/ DCRG/ Commutation of Pension has already been sanctioned in respect of employees retired on or after 1-11-2006.
