Subject: Payment of arrears on account of revision of pay scales under the Himachal Pradesh Civil Services (Revised Pay) Rules, 2009.

Sir,

I am directed to say that vide this Department's letter of even number dated 19<sup>th</sup> March, 2010, out of the total arrears accrued on account of revision of pay scales, an amount of ₹ 10,000/- only was ordered to be paid to all the State Government employees.

2. Now the Governor, Himachal Pradesh is pleased to order that an amount up to ₹ 10,000/- (ten thousand) only, out of the above mentioned balance pay arrears may be paid in cash to the employees in the month of November, 2010, after making necessary adjustments as stated in para 3 below. In case of Government employees whose balance pay arrears are less than the amount of ₹ 10,000/- (Ten thousand), such employees may be paid the actual arrears. The Income tax may be deducted at source, wherever applicable.

3. In case, the amount of "Adjustable Emoluments" as mentioned in O.M Nos. FIN (PR) B (7)-1/2009 dated 9.9.2009 and 12.10.2009, if any, remained unadjusted, the same may be adjusted from the amount of the above said arrear and only the net amount may be paid to the concerned employees.

In case the amount of pay arrear as stated in

Para 2 above is not sufficient to adjust the amount remaining "Adjustable Emoluments" and any amount still remains unadjusted, the same shall be adjusted against future release of pay arrears/increase in pay and allowances.

4. It shall be the responsibility of the concerned DDO to ensure that the entire amounts are adjusted as stated above at the earliest from the arrears and the balance amount may only be paid to the concerned employee.

5. In the case of State Government employees, who, during the above said period worked in different Government Departments or PSUs/Boards/ Corporations of the State Government etc., the arrears may be prepared and disbursed by the concerned State Government Department or PSU/Board/ Corporation etc. where such employees are presently working.
