Essential Educational Qualification required:-

Post No.1- Fisheries Field Assistant:-

1. Matric from a recognized Board or equivalent.
2. Physical Standard:
 - a) Height = 165 cm
 - b) Chest = 79-84 cm
 - c) Speed of foot 16 K.M. within 4 hours & knowledge of swimming.

Post No. 2- Fishermen :-

- (1) Matric from a recognized Board or equivalent.
- (2) Must know swimming.

Post No.3- Peon :-

Middle pass from a recognized Board or equivalent.

Post No. 4- Chowkidar :-

Primary pass from a recognized Board or equivalent.

Terms & Condition:

1. The candidate must have knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in peculiar conditions prevailing in Himachal Pradesh and must be citizen of India.
2. The candidate must be the disabled person of Himachal Pradesh.
3. The age limit for appointment is between 18-45 years. However upper age limit shall be relaxable for the disabled candidates by 5 years.
4. Applicants already in service should send their application form through proper channel with advance copy to the department.

5. A candidate applying for more than one post should send separate application form for each post.
6. The candidates appointed to these posts will be entitled to draw pay & allowances as sanctioned by Govt. from time to time.
7. The appointment carries with it the liability to serve in any part of Himachal Pradesh.
8. Incomplete applications or those received after due date will not be entertained.
9. Canvassing direct or indirect will be a disqualification.
10. The selection for the posts shall be made on Merit basis.
11. The candidates should apply on the prescribed proforma (Annexure-I).

Applications complete in all respects duly supported by attested copies of certificates and testimonials along with disability certificate should reach in the **Directorate of Fisheries, Matsya Bhawan, Bilaspur, HP-174001** on or before **27th December 2007**.
