The Online Applications for enrollment are invited from desirous and eligible candidates for the 700 posts of **Himachal Home Guard volunteers**. Out of 700 posts, 358 vacancies are allocated to General Duty Home Guards (Men), 167 vacancies are allocated to General Duty Home Guards (Women), 74 vacancies to Bandmen, 76 vacancies to Home Guard volunteer Drivers and 25 vacancies are allocated to Technical Trademen Home Guard volunteers.

A. Important Instructions:

1. The candidates must read instructions carefully, which are available on website of the Home Guards and Civil Defence department before applying for the post(s) concerned.
2. The candidates should possess requisite essential qualification(s) prescribed for the post(s) for which he/she wants to apply as mentioned in **Eligibility Criteria** of this advertisement.
3. Date for determining eligibility of all candidates in respect of age shall be 1st January of the year in which the selection/ enrolment is being done.
4. The candidates must upload copies of certificates of Essential Qualification and Matriculation Certificate as proof of age before the closing date of Application to avoid rejection of their candidature.
5. A candidate shall be eligible for recruitment to the post of Home Guard volunteer if he/she has passed matriculation, 10+2 and other higher qualification from any Institution/ School/ Board/ University recognized by the Himachal Pradesh Board of School Education/ UGC as specified in this advertisement.
6. The soldiers released under Agnipath Scheme as Agniveers will also be eligible for enrollment subject to fulfillment of Educational criteria as specified in this advertisement.
7. The candidates are required to apply against the vacancies in respect of their district only.
8. The candidates must mention their e-mail & mobile No. correctly in their Online Recruitment Application for receiving alerts and messages relating to the recruitment process.
9. No candidate shall be admitted to Physical Test without valid proof of identity.
10. All selected candidates shall be required to undergo and pass the Basic Training of 45 days.
11. Disputes, if any, shall be subject to Court jurisdiction at Shimla.

NOTE: The eligibility in technical qualification is subject to the fulfillment of minimum educational qualification of Matriculation. In respect of trades mentioned at Sr. No. 1 to 6, any higher education in the trades will be admissible only if the said course has been done from an institute recognized by the Govt. of H.P.

D. Enrollment Process:

The candidates applying for the post of Himachal Home Guard volunteers shall be admitted provisionally on the basis of their claims made in the online applications and the Enrollment process shall consist of:

d

1. **Physical Standard Test:** The Physical Standard Test (PST) will be scheduled and conducted by the Himachal Pradesh Home Guards and Civil Defence department as follows :-

- a. The candidates must be eligible as per the above prescribed educational qualification, and age criteria. The cutoff date for age will be 1st January of the year in which the selection/ enrolment is being done.
- b. All measurements for height and chest will be taken by a departmental Committee constituted for the purpose which shall be recorded in the candidates' Sheet.
- c. Once the process of PST is over the **candidates who qualify in STAGE -I will undergo the stage-II i.e. physical efficiency test**, which shall be of qualifying nature only and will carry no weightage in the final merit list.

1. The candidates who fail to qualify in any event of PET will be disqualified forthwith and will not participate in the remaining events.
2. During the conduct of the Physical Efficiency Test (PET), videography of every event in the Physical Efficiency Test will be done.
3. The candidate will be required to submit a Certificate of "No Drug Use, or performance-enhancing substances" prior to undergoing the physical tests. Specimen of the certificate is attached as Appendix - A

F. Result of Physical Tests:

After the conduct of physical efficiency tests, Home Guards and Civil Defence department shall provide the list of candidates qualified in the physical efficiency tests. The qualified candidates will be admitted to stage-III.

Merit will be drawn on the marks obtained in Matriculation.

3. **FINAL SELECTION:**

The final merit list will be drawn by the enrolment board on the basis of the marks obtained in the stage-III. The final enrolment will be made on the basis of this merit list, subject to satisfactory verification of character and antecedents, medical fitness and verification of testimonials.

If two or more candidates score equal marks in the stage-III, then candidate who is older in age will be placed above the candidate younger in age. In case the age is also same then the candidate having more marks in the essential qualification examination will be placed above the candidate having fewer marks.

The DOPE test of the selected candidates will be conducted by the Medical Professional detailed by the CMO office of the respective District during the Medical Examination of the selected candidates.

J. **How to Apply:**

1. Desirous/ eligible candidates have to apply online through official website of the Himachal Pradesh Home Guards Department i.e. <https://himachal.nic.in/homeguard> Applications received through any other mode would not be accepted and will be rejected straight away.

2. The desirous and eligible candidate may visit the official website of the Himachal Pradesh Home Guards official website i.e. - <https://himachal.nic.in/homeguard> & Home Guards volunteers Recruitment Portal <https://hgvr.hp.gov.in/HPHG/ApplicantRegistration/Home/Login> and click on the link - Apply Online on the Home Page. On the opened page the candidate will click on the link —One Time Registration (OTR) and register his / her profile by clicking on —“**New Registration**” if not registered already. After registration or if already registered the candidate will have to log into his/ her account in ORA

page. After filling all the requisite information, **the list of live advertisements** will be displayed to the candidate on the dashboard. After going through the advertised posts in the list, the Candidate will apply for particular post and upload the requisite documents. Before submission of application, the candidate will have to give an undertaking/ declaration that:- "It is certified that I have checked the preview of all the requisite uploaded documents and I am satisfied that documents are legible, readable and true. That I shall not object to rejection of my candidature based on the sole reasons of uploaded documents being nonreadable/ poor quality of scanning."

3. The candidate shall pay the requisite fee..
4. No change will be allowed in the Online Recruitment Application (ORA) once submitted.
5. Application without scanned latest photograph and signature shall be rejected straightaway.
6. The One Time Registration (OTR) of the candidates will commence w.e.f. 25th February, 2026 onwards and the submission of online application process will commence on 2nd March 2026 and both the processes will remain open until 31st March 2026, 23:59 Hrs. which is the last date for the submission of online applications
7. The schedule for the Physical and Written Examination will be intimated via the Admit Card through Home Guards Recruitment Portal.

K. Venue for Conduct of Enrollment Process:

The process of conducting the enrollment of home guards is done district-wise thus the physical test shall be held at the location and on the dates to be decided by the Chairman of the Enrollment Board of the concerned district.

M. Mode of Payment:

1. The desirous & eligible candidates shall pay the fee online by Debit Card/ Credit Card/ UPI/ any other online digital mode, as the case may be, on or before

the prescribed closing date for submission of Online Recruitment Applications on OTR portal. Fee once paid shall neither be refunded nor can it be held in reserve for any other examination or selection.

2. Candidates should note that payment of fee can be made only through the modes prescribed above. Payment of fee through any other mode is neither valid nor acceptable. Applications submitted without the prescribed fee/mode shall be summarily rejected.

N. Original certificates will have to be produced at the time of Document verification and if claim of any candidate is found to be incorrect; their candidature will be rejected.

O. E-Call Letters:

1. E-Call Letters / admit cards will NOT be sent by post and provisionally admitted candidates shall have to download their respective e-Call Letters / admit cards along with instructions for the concerned examination. i.e. physical test., document verification etc from the official website.

2. In addition to the Admit card, it is mandatory to carry original valid Photo-ID proof having the **date of birth** printed on it such as:

- Aadhaar Card/ Printout of E-Aadhaar.
- Driving License,
- PAN Card,

P. General Instructions:

1. Candidates should exercise due care while entering their date of birth in relevant column of the application Form. If on verification at any subsequent stage, any variation is found in their date of birth from the one entered in their Matriculation Certificate their candidature shall be liable to be cancelled.

2. The applicant shall upload his/her latest photograph in the space provided in the application form. In case, photograph uploaded on the application is found to be different/ varying to that of pasted on the admit card for appearing in the physical, etc., the candidature of such candidates shall stand cancelled.

3. It may be ensured by the candidates before submitting the applications that furnishing of false information and documents or suppression of any factual



information in the application form would entail disqualification.

4. If any candidate at any stage of selection is found to be guilty any of the following shall be liable for criminal prosecution in addition to his/ her disqualification from the enrollment process:-

- (i) Impersonating; or
- (ii) submitting false/ fabricated documents or documents which have been tampered with;
- (iii) Flouting any Instructions Guidelines, terms and condition, given in advertisements or instructions communicated in any manner or suppressing material information at any stage of selection;
- (iv) Harassing, threatening or causing physical injury to the staff engaged in the conduct of Physical Test or Evaluation/ Document Verification;
- (v) Violating any of the instructions given to the candidates in their admission card or other staff engaged in the conduct of Physical Test or Evaluation / Document Verification;
- (vi) Being in possession of or using mobile phone, pager, scanner or any electronic equipment or device or any other equipment capable of being used as a communication device during the Physical Test or Evaluation / Document Verification/ written Test;

5. The candidates applying for the post of Bandman shall ensure that they mention the type of instrument for which they are applying. For instrument wise vacancy candidate can refer to para B(1) of this advertisement.

6. In case any vacancies of any trades remain vacant due to non availability of suitable candidates, then such vacancies shall be filled up from the waiting lists prepared for the General Duty Home Guard volunteers in their respective Districts.

Q. Written Test:

The written test will carry 50 marks and will have four sections namely Hindi, English, mathematics and General Knowledge pertaining to Himachal Pradesh. Hindi, English and Mathematics section will carry 12 marks and G.K. section will carry 14 marks. Each section will have questions of objective types pattern and the examination will be of 1 hour duration. The syllabus for written
