The above regularization/promotion will be to the Tehsildars who are in service except the Naib Tehsildars who stood retired as keeping in view the instructions of Department of Personnel dated 25-06-2013 such retired officers would, however, have no right for actual promotion and also that promotions will have only prospective effect even in cases where the vacancies relate to an earlier year. The above officers (except retired Tehsildars) may exercise option for fixation of pay under Fundamental Rule-22 (1) (a) (i) within one month, if already not exercised.
