A candidate shall be eligible for Class IV post (s), if he/she has passed Middle or Matriculation from any School/Institution situated within Himachal Pradesh. Provided this condition shall not apply to Bonafide Himachalis.
Desirable Qualification	Knowledge of customs, manner and dialects of H.P. and suitability for appointment in the peculiar conditions prevailing in the Pradesh.
Other eligibility criteria	1. The age of candidates should be between 18 to 45 years as on 01-01-2019. 2. Provided further that upper age limit is relaxable for Scheduled Castes/Schedule Tribes/Other categories of persons to the extent permissible under the general or special order (s) of the Himachal Pradesh Govt.
Terms and Conditions	All the terms and conditions as laid down in the R&P Rules of the Peon shall be applicable.


